ACTUAL STATUS OF EU ENVIRONMENTAL ACQUIS (Chapter 27) IN SERBIA shows that Actual Government is keeping environmental approximation "on hold" (one of the evidence is The Law on budget for 2013). Rebuilding (after broken continuity in 2012) and further strengthening of the relevant institutions and of the administrative (human/personal) capacity should remain a new strong priority. In the last year, numerous changes of laws and secondary legislation relevant to environment sector, took place. This should be carefully monitored – because the changes could lead to approaches less accepting EU guiding principles than previous ones. There is a need for enforcement of implementation of environmental legislation – the measures should be link with the inclusion of environment in the other sector policies, including the justice system and financial control mechanisms.

With abolishment of Environment Fund in 2012, good tool/mechanism /economic instrument for enforcement are lost, and substitution mechanism is not developed. Environmental infrastructure priorities (as noted in NEAS, RIO+20 document, Draft Fiscal Strategy, etc) should be built in accordance with plan. How
